To do so in Illinois, you must register your assumed name with the Illinois Secretary of State. You may register online, or by postal mail by filing an Application to Adopt, Change, Cancel, or Renew an Assumed Name (Form LLC-1.20). The registration is good for up to five years. The filing fee is \$30 per year, up to \$150.
